### A. Personal Statement

Dr. Roy William Mayega is a Lecturer in the Department of Epidemiology and Biostatistics, at the School of Public Health, Makerere University, teaching Epidemiology and Research Methodology to both graduate and undergraduate students. He is also the Instructional Materials Designer and Editor for the MPH Distance Education program at MakSPH. He underwent basic training as a Medical Doctor at Makerere's Medical School. He received a Master's Degree from Makerere and a PhD in Medical Science from Karolinska Institutet Sweden. Dr. Mayega has accumulated atleast 20 years of experience in public health related work, 6 of which were spent at primary care level. He worked in Kiboga District Local Government, as a Medical Officer, Assistant Director District Health Services and Acting Director District Health services Upon completion of his MPH training, Dr. Mayega joined Makerere's School of Public Health in January 2006, as a Research Fellow and Assistant Lecturer. From 2006 to 2012, he worked as an Instructional Materials Designer/Editor for the Master's Degree in Public Health by Distance Education. Dr. Mayega was appointed to the position of Lecturer, Department of Epidemiology and Biostatistics in August 2012, which he has held since then. He has supervised 21 graduate students at Master's degree level to completion of their studies and is currently supervising three PhD students.

Dr. Mayega's current research interests include non-communicable disease control, disaster risk reduction, resilience and innovation. The focus of his PhD studies was type 2 diabetes, resulting into a thesis entitled: Type 2 Diabetes in Rural Uganda: Prevalence, risk factors, perceptions and implications for the health system (published May 2014). Dr. Mayega is co-investigator of a multi-country research group that is conducting a cluster randomized trial to test an innovative intervention for integration and improvement of prevention and care for type 2 diabetes at primary care levels in different socio-economic settings (SMART2D), where he is a co-investigator. Dr. Mayega is extensively experienced in Resilience programming. He has developed this experience from being part of the following programs:
